THE ASSOCIATION ASSISTS THOSE IN NEED BY PURCHASING GLASSES AND READING AIDS. COMPUTER CLASSES ARE ALSO CONDUCTED ON A REGULAR BASIS. THE ASSOCIATION ALSO PROVIDES HIGHLY QUALIFIED INSTRUCTORS TO TEACH MOBILITY TRAINING AND LONG CANE TRAVEL AND FUNCTIONS. THE ASSOCIATION OPERATES A SHELTERED WORKSHOP THAT PROVIDES TRANSITIONAL AND EXTENDED EMPLOYMENT FOR THE BLIND.
