 Chartered in 1979, AGA began a process of transforming slum conditions in the Avenida Guadalupe neighborhood first constructing the UDAG funded Plaza Guadalupe in 1984, El Panan in 1991, El Progreso Theater in 1996, and Las Oficinas in 2004 Since then, AGA maintains a co-ownership contractual relationship with the City of San Antonio to operate and manage neighborhood service and commercial properties in the Avenida Guadalupe Project area ensuring access to a neighborhood dentist, an American Indian cultural organization, a womens arts cooperative, workforce services both for workforce training and job placement, immigrant services, and teen workforce, amongst other amenities AGA also maintains and provides venues for public assembly and for special event use making rental costs affordable to non-profit neighborhood service agencies, organizations, and businesses promoting and celebrating Hispanic culture to generate and maintain vitality and development in the neighborhood please see continuation on Schedule O under 990, Part III, 4a








 The AGA offers community empowerment, advocacy, and engagement activities, including workforce development training and placement, to local tenants and residents within the Avenida Guadalupe Neighborhood area In partnership with AARP Foundation Senior Community Service Employment Program SCSEP, AGA assists low-income, unemployed individuals aged 55 find work, increase skills, and build self-confidence while earning a modest income Since its inception, AGA has provided housing services including first-time homebuyer education classes, credit repair programs, and currently manages a downpayment assistance program AGA, having constructed the San Jacinto Senior Housing Community in 1996, maintains and manages a TDHCA funded 50-unit elderly residence complex in the Avenida Guadalupe project area Additionally, in 2002 and then in 2005, AGA sponsored two HUD 202 PRAC Senior Housing Communities Ernest Olivares Senior Apartments and the Charles Gonzales Senior Homes, both currently managed by Avenidas housing department, AVEGU

 The AGA offers culturally significant events that educate and provide the community with opportunities to experience traditional Mexican holidays such as Cinco de Mayo, Diez y Seis de Septiembre, and Una Noche en La Glona Hispanic Heritage Month Avenidas cultural activities promote and celebrate Hispanic Mexican American culture to generate and maintain vitality and development in the Avenida Guadalupe project area Event vending and other income-generating activities provide opportunities for area non-profit organizations to fundraise for scholarships, school supplies, needed clothing for the poor, and gap-operating income for fledgling organizations which provide services to the community AGA recognizes its cultural activities as mechanisms that promote neighborhood commercial revitalization in what is considered to be the poorest neighborhood in the city of San Antonio
