Permanent Supportive Housing SHP - SHP is an innovative program whose goal is to provide a supportive environment for homeless families while helping them attain the highest level of self-sufficiency. To meet eligibility requirements, the family must be homeless and come from places not meant for human habitation such as cars, parks, sidewalks and abandoned buildings an emergency shelter or a transitional housing program for homeless persons that originally came from the streets or emergency shelter. In addition, only homeless families with one of its members having a qualifying disability are eligible for the SHP program. This past year SAMMinistries housed 206 households made up of 729 formerly homeless individuals

4b (Code) (Expenses \$ 3,133,936 including grants of \$) (Revenue \$ 2,781,178)

Transitional Services - Transitional living and learning center TLLC and Transitional Housing TH in 2000, we expanded our programs and facilities to include transitional housing for families at the transitional living and learning center TLLC on Blanco Road. We also have 25 scattered site houses. Both programs allow up to 65 families who meet specific criteria to stay for up to 24 months. Our families are offered classes including life-skills building, money management, parent nurturing, resume writing, and GED exam readiness. In FY 2016 the TLLC and TH programs provided safe housing for 100 families 348 individuals

Homeless Prevention Services - SAMMinistries has been working with the general community in addressing the barriers that contribute to families and individuals becoming homeless. These barriers are being addressed through community collaboration and through providing direct financial assistance to families and/or individuals who qualify for rental and utility assistance. In FY 2016 SAMMinistries prevented 3,756 individuals 1,584 families from becoming homeless. With a combination of private and public funding, SAMMinistries has become the largest provider and community leader in the area of homeless prevention services
