Energy Outreach Colorado (EOC) is an independent, non-profit organization that raises funds to help low-income Coloradans afford home energy. Since 1989, EOC has distributed \$200 million for energy bill payment assistance, energy efficiency upgrades for affordable housing and non-profit facilities, energy efficiency education, and advocacy on behalf of low-income energy consumers. EOC funds are distributed as grants to emergency assistance and affordable housing organizations across Colorado.

This database collects details of clients' name, address, demographic information, income data, housing data, and utility vendor information. The program manager checks on a regular basis to see that funding is being distributed to the relevant vendors. Each client may only receive assistance once during a grant year (November 1 through October 31), should two agencies pay for the same client in a grant year then one of the payments is disallowed and the agency must pay for the bill with other than EOC's grant funds.
