UNTIL JUNE 5, 2016 THE ORGANIZATION PROVIDED WHOLE BLOOD AND COMPONENTS TO 29 HEALTHCARE FACILITIES PRIMARILY LOCATED IN THE TOP 29 COUNTIES IN THE TEXAS AND OKLAHOMA PANHANDLES.
