artists/groups on six stages including a dance pavilion dedicated to participatory  
dancing, a family state with performances appealing to children of all ages, and a  
Montana folklife stage. Admission throughout the three-day festival is free for  
everyone. The festival attracts an estimated 170,000 visitors annually to Butte,  
Montana's National Historic Landmark District.
