GRAND TETON NATIONAL PARK FOUNDATION PROVIDED FUNDING TO GRAND TETON NATIONAL PARK FOR INSPIRING JOURNEYS. A CAMPAIGN FOR JENNY LAKE THIS RESTORATION CAMPAIGN WILL SIGNIFICANTLY UPGRADE THE SOUTH JENNY LAKE VISITOR COMPLEX AND TRAILS/BRIDGES TO HIDDEN FALLS AND INSPIRATION POINT, IMPROVING HIKING SURFACES AND VIEWING AREAS, INTRODUCING INTERPRETIVE MATERIAL, AND UPGRADING SIGNAGE TO CLARIFY WAYFINDING. THE PROJECT WILL ULTIMATELY CREATE A SUSTAINABLE OUTDOOR VISITOR CENTER AND TRAIL SYSTEM THAT WILL MAINTAIN THE HISTORIC CHARACTER OF THE AREA, YET IMPROVE SAFETY, ENGAGE VISITORS, AND AID THE PARK IN MAINTAINING THIS POPULAR DESTINATION.

IN ADDITION TO THE JENNY LAKE PROJECT AND YOUTH AND WILDLIFE INITIATIVES OUTLINED IN 4a AND 4c, THE FOUNDATION FUNDED HISTORIC PRESERVATION WORK AT THE MORMON ROW AND LUCAS-FABIAN HOMESTEADS, TWO OF THE MOST POPULAR CULTURAL SITES IN GRAND TETON. INTERPRETIVE TRAILS WERE CONSTRUCTED AND CABINS RESTORED AT LUCAS-FABIAN. A BUS TURNAROUND, EXPANDED PARKING, AND A BATHROOM WERE INSTALLED AT MORMON ROW. A NEW HAMMER CORP VOLUNTEER GROUP PROVIDED LABOR FOR THE CULTURAL RESTORATION PROJECTS. WINTER TRAIL GROOMING OF THE INNER LOOP ROAD IN GRAND TETON CONTINUED AS WELL, PROVIDING IMPROVED CONDITIONS FOR SKIERS, SNOWSHOERS, AND WALKERS GREATLY BENEFITING WINTER VISITORS TO THE PARK.

GRAND TETON NATIONAL PARK FOUNDATION PROVIDED FUNDING TO GRAND TETON NATIONAL PARK FOR THE WILDLIFE AND NATURAL RESOURCE INITIATIVE. FUNDING SUPPORTED RESEARCH AND CONSERVATION PROGRAMS FOR A WIDE VARIETY OF SPECIES AND THEIR HABITAT. THE FOUNDATION'S ANTELOPE FLATS CAMPAIGN WILL PROTECT 640 ACRES OF PRIME SAGEBRUSH STEPPE HABITAT. SCIENTIFIC EQUIPMENT, SUCH AS GPS TRACKING COLLARS, WERE PROVIDED BY FOUNDATION DONORS AND USED BY BIOLOGISTS TO GATHER CRITICAL DATA FOR INFORMING TACTICAL AND STRATEGIC MANAGEMENT DECISIONS AT THE PARK, ECOSYSTEM AND STATE LEVELS. PRIVATE FUNDING ALSO FACILITATED THE DEVELOPMENT AND IMPLEMENTATION OF PUBLIC EDUCATION PROGRAMS THAT FOCUSED ON WILDLIFE CONSERVATION AWARENESS. IN ADDITION, FOUNDATION FUNDING BROUGHT BEAR RESISTANT FOOD STORAGE BOXES TO CAMPSITES IN THE PARK. THESE LOCKERS GIVE PARK VISITORS A PLACE TO SAFELY STORE FOOD AND OTHER BEAR ATTRACTANTS, HELPING TO KEEP BEARS WILD AND AWAY FROM DEVELOPED AREAS. THESE METAL BOXES PREVENT FOOD CONDITIONING OF BEARS AND AGGRESSIVE BEHAVIOR THAT USUALLY FOLLOWS, WHICH ALSO HELPS PROTECT VISITOR SAFETY.
