CHEEERS EXPANDED PROGRAMMING DURING THE YEAR TO INCLUDE A BROADER ARRAY OF SERVICE OPTIONS AVAILABLE TO PARTICIPANTS. NEW GROUPS AND CLASSES WERE ADDED TO PROVIDE EDUCATION AND SUPPORT FOR THE MANAGEMENT OF CHRONIC HEALTH ISSUES, AND FOR THE DEVELOPMENT OF LIFE AND COPING SKILLS. CHEEERS IS A CONSUMER OPERATED SERVICE PROGRAM (COSP). THE SUBSTANCE ABUSE AND MENTAL HEALTH ADMINISTRATION HAS ESTABLISHED TOOLS TO MEASURE COMPLIANCE WITH ESTABLISHED PRINCIPLES FOR COSP'S.
