Construction, Inc. or it's parent company, The Sundt Companies, Inc.

non-employee membership. A Sundt employee becomes a member by contributing \$5 or more per year. Membership

entitles an employee to vote in accordance with the bylaws and to hold elective office. A non-employee becomes a

member by contributing \$5 or more per year. Non-employee members are non-voting members.

Form 990, Part VI, Section A, Line 7a: The Board of Directors,consisting of at least nine members but not more than fifteen

members, controls all activities of the Sundt Foundation. The Sundt Companies, Inc. appoints four directors. The

remaining directors are elected by the membership, with one director serving from each of the principal geographic areas

where Sundt has an office or subsidiary company and serving staggered three-year terms.

Form 990, Part VI, Section A, Line 7b: Decisions by the Board of Directors are not subject to approval by members or other persons.

Form 990, Part VI, Section B, Line 11b:The Form 990 is reviewed by members of the Board of Directors and the CFO of The Sundt Companies.

Form 990, Part VI, Section B, Line 12c: An annual letter is sent to all officers and directors requiring them to disclose any

possible conflicts of interest.

Form 990, Part VI, Section C, Line 19: The Sundt Foundation makes it's governing documents, conflict of interest policy,

and financial statements available to the public upon request.
