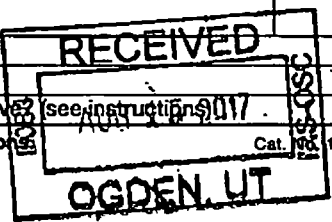

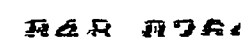

Protection and Advocacy for Individuals with Developmental Disabilities Program (PADD)
 Numbers served: In 2016, DRW's PADD program provided advocacy services to 42 different groups with the potential of impacting 40,162 individuals with developmental disabilities. The number receiving individual advocacy services was 77 with 717 received training from our PADD program while 12,439 received information and referral services. 29 publications were revised or created and 75,182 visited our websites.
 Advocacy Example: In 2016, DRW continued its efforts to advocate for people with disabilities to live in community settings rather than institutions. DRW identified 41 individuals currently living in the community but not receiving supported living services, despite being eligible to receive them. DRW also found 50 individuals living in Residential Habilitation Centers eligible and interested in living in the community but were unable to do so because of a lack of providers. After an extensive investigation and negotiations, a lawsuit was filed in federal court to enforce people's rights to live in the community and is currently ongoing.

4b (Code:) (Expenses \$ 604,525 including grants of \$) (Revenue \$ 409,557)
Protection and Advocacy for Individuals with Mental Illness Program (PAIMI)
 Numbers served: In 2016, DRW's PAIMI program provided advocacy services to 92 different groups with the potential of impacting 210,524 individuals with mental illness. The number receiving individual advocacy services was 354 with 1,675 received training from our PAIMI program at 49 events while 11,310 received information and services.
 Advocacy Example: In 2016 DRW investigated the high number of deaths at a specific jail over the past few years. The jail provided voluminous written records but refused to provide a video of a restraint incident that led to the death of an inmate and was later ruled a homicide. DRW and the jail exchanged numerous calls and letters but the jail refused to provide the video citing security concerns but refused to provide specific examples. DRW filed a lawsuit for access to the video. The jail and DRW discussed the possible security concerns and DRW provided suggestions to address any possible security concerns. The jail then provided an unredacted full version of the video to DRW and the case was dismissed. DRW is continuing its investigation.

4c (Code:) (Expenses \$ 367,503 including grants of \$) (Revenue \$ 18,779)
Protection and Advocacy of Individual Rights Program (PAIR)
 Numbers served: In 2016, DRW's PAIR program provided individual advocacy services to 376 individuals with 1,285 receiving training from 38 different training events. DRW had 75,182 individuals visit our websites and provided advocacy services to groups potentially impacting 315,020 individuals.
 Advocacy Example: In 2016 DRW launched an investigation into the conditions of confinement for inmates with disabilities at the Yakima County Jail, confirming significant legal violations related to access to mental health care, use of segregation and provision of auxiliary aids among other things. DRW monitored the jail repeatedly and provided technical assistance while at the facility. DRW reviewed records for 17 inmates along with the jail policies. After a lengthy investigation including inmate interviews, the jail staff agreed to meet with and work with DRW to correct inadequacies at the jail, including providing psychiatric medication and a timely response to serious mental or medical issues. DRW proposed structured negotiations to address the jail's failure to adequately treat and accommodate inmates with disabilities. The negotiations are ongoing.

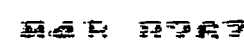

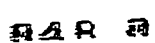

Once a year the topic is discussed and individuals are required to sign a code of Ethics Certification form. The matter of whether or not a conflict actually exists is decided by majority vote of the members present of the Board or Council, excluding the member with the member with the potential conflict. If it is determined that a conflict exists then actions may range from excluding the member from participating in discussions on the matter with which they have a conflict to the Board asking the member to step down.
