CASCADE ANIMAL PROTECTION SOCIETY ADOPTED OUT 104 CATS AND 7 DOGS. LOW INCOME AND SENIOR CITIZENS WERE ISSUED 66 CERTIFICATES THAT ENABLED THEM TO SPAY AND NEUTER THEIR COMPANION CATS AND DOGS. EMERGENCY VETERINARY TREATMENT WAS PROVIDED TO 120 ANIMALS WHOSE OWNERS COULD NOT AFFORD TO PAY FOR TREATMENT. THOSE ANIMALS WOULD HAVE GONE UNTREATED WITHOUT OUR ASSISTANCE.

FOSTER CARE WAS PROVIDED TO ALL THE ADOPTED CATS AND DOGS PRIOR TO THEIR ADOPTION. LONG-TERM FOSTER CARE WAS PROVIDED FOR 37 CATS AND 3 DOGS.

WE ALSO ASSISTED PEOPLE IN PREPARING FOR THE CARE OF THEIR ANIMALS IN CASES OF SUDDEN ILLNESS OR DEATH. EVERY RESCUED DOG AND CAT WAS MICROCHIPPED TO AID IN LOCATING THEM SHOULD THEY GO MISSING.
