Food Distribution - The Food Bank, which operates like a grocery store, distributes food to those seeking assistance from Ballard, Magnolia and Queen Anne. The Food Bank and home delivery program served 39,908 households through the 2015-16 year. This fed 57,131 individuals and families over the course of the year. The Sack Lunch program is available for clients during Food Bank hours. The Weekend Food for Kids program provided 7,359 bags of meals and snacks for the weekend to more than 250 students in 15 schools during the school year, including weekend bags of food for 75 students at 10 community partner sites during the summer. 1,520,008 pounds of food were distributed through the Food Bank.

Client Services - 708 individuals were provided assistance through our Financial Assistance Program where they receive utility and rent assistance as well as vouchers for Washington State Identification vouchers. The Organization provided a mailing address for 525 clients to receive and pick up mail. The Personal Hygiene program distributes supplies to clients on a weekly basis.
