An annual work plan is developed and approved by the OSRI Advisory Board. OSRI funds are given directly by the USCG Dept of Treasury to the PWSSC, who has the fiduciary responsibility for these funds. These funds received from the USCG Dept of Treasury are treated as federal for reporting purposes. These awards include grants and service contracts included in the work plan. Proposals are accepted through the advertised Request for Proposal (RFP) process or by a request for a proposal to a specific entity to meet the work plan needs. These proposals are peer reviewed by OSRI's Science & Technology Committee. If approved, they then go to the Board Chair (appointed by U S Secretary of Commerce) who approves. The grants are then awarded or amended if from prior years. Deliverables, financials and reporting expectations are included in the award documentation and the Grant Policy Manual is also found online on the OSRI web site www.pws-osri.org . Because the original source of these funds are from the Trans Alaska Pipeline Fund, these funds can be used for matching purposes on other federal awards.
