ARCTIC LOGISTICS AND COMMUNITY SCIENCE PLANNING: These activities coordinate science planning across disciplinary, organizational, sector, cultural, and geographic boundaries in support of the Arctic Research community. ARCUS is the Project Office for the Study of Environmental Arctic Change (SEARCH), which focuses on advancing key cross-cutting research priorities to understand the changing Arctic. ARCUS uses partnerships, workshops, committee activities, and online communications to bring together the Arctic research community, along with its funders and stakeholders. In this year, ARCUS convened an Arctic Observing Open Science Meeting to facilitate and advance the progress of Arctic observational science. ARCUS activities help define, coordinate, communicate, and support shared priorities and initiatives. ARCUS works with the U.S. Interagency Arctic Research Policy Committee providing operational and strategic-level support and bringing research community perspectives to inform the U.S. government 5-Year Arctic Research Plan. ARCUS provides project management support, facilitation, administrative, logistical, and travel support and maintains a comprehensive website and publication archives to communicate these activities.

OUTREACH AND INFORMATION: ARCUS supports communication across boundaries by serving as a channel providing valuable information about the wide range of Arctic research efforts to the research community, other stakeholders, and to the public through online tools, publications, and in-person and virtual meetings. ARCUS provides the venue where Arctic research connects. Key activities include the Arctic Research D.C. Seminar/Webinar Series, the ArcticInfo email list, the comprehensive global Directory of Arctic Researchers and Calendar of Arctic Research Events, reinvention of the Witness the Arctic Newsletter, the Internet Media Archive, and other resources. ARCUS also operates informally to make many connections across disciplinary, organizational, sector, cultural, and geographic boundaries that advance communication, coordination, and collaboration in Arctic research, education, and outreach. In the education arena, PolarTREC supports the development of outstanding educational leaders by placing them within a Polar research team. The Arctic in the Classroom connects rural Alaska teachers with researchers working in their communities to engage students and residents in the research projects which affect them. Sea Ice for Walrus Outlook engages coastal Arctic Alaska communities in dialogue with the Sea Ice Prediction Network and the National Weather Service about local conditions to enable safe subsistence activities on the ice.
