THE COOKIE PROGRAM ALLOWS GIRLS, TROOPS, AND SERVICE UNITS TO EARN RECOGNITION AND REWARDS THAT THEY CAN USE TO PAY FOR GIRL SCOUT PROGRAMS OR CAMPS. 2,018 GIRLS PARTICIPATED IN THE
