SOCIAL SERVICES - THE ORGANIZATION PROVIDES FOOD, CHILDREN'S CLOTHING, VISION EXAMS AND EYEGLASSES, PRESCRIPTION MEDICATION ASSISTANCE, RENT AND UTILITY ASSISTANCE, AND OTHER EMERGENCY AND TEMPORARY SERVICES TO INDIVIDUALS AND FAMILIES IN THE LOCAL COMMUNITY WITHOUT CHARGE. DURING THIS FISCAL YEAR, WE FED 4,292 FAMILIES, WE CLOTHED 194 CHILDREN, AND WE PROVIDED SPECIAL ASSISTANCE TO 448 FAMILIES. THE SPECIAL ASSISTANCE INCLUDES UTILITY ASSISTANCE, PRESCRIPTION ASSISTANCE, AND SIMILAR ESSENTIAL NEEDS ALL IN THE FORM OF VOUCHERS OR DIRECT SERVICES.

COUNSELING AND PASTORAL SERVICES - THE ORGANIZATION PROVIDES INDIVIDUAL AND FAMILY MENTAL HEALTH COUNSELING, GRADUATE AND POST GRADUATE TRAINING AND INTERNSHIP. WE CONDUCT EDUCATION AND TRAINING PROGRAMS FOR COMMUNITY, PROFESSIONALS AND CHURCHES. THE ORGANIZATION ALSO PROVIDES PASTORAL AND SPIRITUAL CARE BY A PRIEST/CLERGY ON SITE FOR BOTH STAFF AND CLIENTS. PASTORAL CARE INCLUDES PRAYER AND WORSHIP FOR EVERY-DAY LIFE, CELEBRATIONS AND TRANSITIONS AND HOLY DAYS, PASTORAL COUNSELING AND SPIRITUAL SUPPORT, PASTORAL VISITS, REQUESTS FOR PRAYER AND BLESSINGS, AND OCCASIONAL PROGRAM ACTIVITIES TO SUPPORT SPIRITUAL WELL-BEING DURING THIS FISCAL YEAR, WE PROVIDED COUNSELING TO 443 FAMILY/INDIVIDUAL EQUIVALENTS. ALL FAMILIES/INDIVIDUALS RECEIVED AN AVERAGE OF 9.46 SESSIONS OF COUNSELING. THESE SERVICES WERE PROVIDED AT AN AVERAGE COST PER SESSION OF \$37.03 (NOT COUNTING IN-KIND DONATIONS), THE FAIR MARKET VALUE OF EACH SESSION WAS \$90. PROFESSIONAL CLINICAL SUPERVISORS OBSERVE 85% OF OUR CLIENTS COMPLETING THEIR COUNSELING GOALS. ALCOHOL/DRUG ABUSE IS A FACTOR IN APPROXIMATELY 80% OF OUR COUNSELING CASES.

THRIFT STORE - THE ORGANIZATION OPERATES A THRIFT STORE IN THE PORTLAND METROPOLITAN AREA, THE NET EARNINGS OF WHICH SUPPORT DIRECT SERVICES TO CLIENTS. THE STORE FUNCTIONS AS A CLOTHING AND HOUSEHOLD GOODS SUPPLY CENTER FOR SOCIAL SERVICE CLIENTS. DURING THE FISCAL YEAR ENDED 9/30/16, WE HAVE PROVIDED LOW COST CLOTHING AND/OR HOUSEHOLD ITEMS TO 64,242 PEOPLE. OUR AVERAGE SALE IS \$13.46, AND OUR COST TO PROCESS DONATIONS AND OPERATE OUR STORE FOR THAT SAME SALE IS \$9.42, GENERATING 30% "PROFIT" WHICH SUPPORTS COUNSELING AND SOCIAL SERVICES.
