Form 990, Part III, Line 1	Immigration Project The Immigration Project prides itself on the work it does to empower immigrant communities in rural California with knowledge about their existing rights while also offering free direct legal services when possible. Over the past year, our program has provided over 50 in-depth community presentations from Redding to Fresno. With the assistance of almost 140 volunteers, the Immigration Team provided over 500 legal screenings and assisted over 300 individuals apply for Deferred Action for Childhood Arrivals or for naturalization. CRLAF is also a lead partner in the Greater Sacramento Partnership Against Trafficking. The collaborative offers comprehensive services to survivors of labor and sex slavery, including counseling, case management, law enforcement advocacy, public assistance, and legal assistance. CRLAF's primary role in this partnership is to provide legal services for those survivors who are undocumented and eligible for T Visa relief. The Litigation Unit The Litigation Unit at CRLAF represents workers in agricultural and other low-wage industries in rural communities when employers try to avoid liability through labor contracting systems and where workers' fear of retaliatory deportation makes them especially vulnerable. CRLAF settled a total of three class actions and two individual cases recovering \$2.5 million in back wages for an aggregate of 360 low-wage workers. Housing Unit CRLAF's Rural Housing Project represents the interests of the rural poor and farmworkers in advocating on state housing policy, both legislative and administrative. Incentivizing affordable housing CRLAF has played a major role in helping to establish and improve the state Density Bonus law. The law provides incentives to developers of affordable housing to help target the units to lower-income families, and provides significant incentives to developers of market-rate housing to include affordable units in their developments. Signed by Governor Brown, AB 2501 (Bloom) closes a number of loopholes that are used to block or discourage projects. CRLAF has worked to strengthen state law that gives tenants and nonprofit developers an opportunity to purchase and preserve affordable housing that is at risk of converting to market-rate because the affordability restrictions have reached their end. A technical change at the federal level risked excluding a number of properties financed with mortgage revenue bonds. CRLAF helped to fix state law to protect those properties. CRLAF launched an initiative to help preserve mobile home parks as a critical source of affordable housing and protect homeowners from abuses. As part of that, CRLAF has helped improve protections for residents, including working with the state Department of Housing and Community Development to clarify a prior bill by CRLAF that helped dedicated several million dollars in state funding for rehabilitation of mobile homes owned by low-income homeowners. This year, legislation would make clear that the money can be used to fully replace a very dilapidated home, rather than just repair it. Sustainable Rural Communities Project The Sustainable Rural Communities Project seeks to merge many of our organization's longstanding direct services and advocacy issues into an approach that addresses the systemic causes of our communities' poverty, poor health and degraded environment. The project has advocates working together on a coordinated local, regional, and statewide strategy that is crafting systemic solutions around healthcare for all, environmental justice issues (land use, unmet transit needs, water quality), fostering more accountable and inclusive governance, and directing financial resources that address the priorities of the SRCP to rural and disadvantaged communities. Pesticide and Work Safety Project The CRLAF Pesticide and Work Safety Project advocates for social justice for farmworkers and other low-income rural residents through working to improve enforcement of existing state and federal occupational safety and pesticide use restrictions for agriculture and advocating for more protective laws and regulations. In collaborations on pesticide and work safety policy we analyze illness, injury, pesticide use, toxicity and enforcement data, participate in informal and formal stakeholder meetings with agencies, serve on state advisory committees and draft technical comments on regulatory proposals. CRLAF is one of the few organizations with a project based in Sacramento with an in-depth working knowledge of agricultural worker pesticide. Improvement in California's Pesticide Air Monitoring Network The California Department of Pesticide Regulation (DPR) has been conducting air monitoring of pesticide levels in several rural communities since 2011 but sampling locations are poorly chosen. CRLAF has led the critique of DPR's annual monitoring reports and misleading press statements claiming that these results are representative of maximum pesticide air levels in California. As a direct result, DPR is relocating two of three air monitoring sites to areas of higher pesticide use and expand air monitoring at better situated Air Resources Board (ARB) sites. Scope Broadened for Repeat Violations of Work Safety Regulations We collaborated with other organizations to ensure that amendments to Cal-OSHA regulations (Title 8 Section 334(d)) will increase the look back period from 3 years to 5 years for all repeat work safety violations and broaden the definition of repeat violations to "substantially similar hazards and conditions." These changes were needed to achieve consistency with both the California Labor Code requirements for field sanitation violations and federal OSHA requirements and they will level the playing field for employers who invest in safety but they still faced fierce industry opposition.
