APCA distributed \$156,400 in scholarships to 114 graduating high school seniors, undergraduate and graduate students who have been accepted or studying in accredited universities. Students who applied online had to submit their transcript showing they had a GPA in excess of 3.5 on a 4.0 point scale, send a letter of recommendation, write an essay on a topic we provided, and demonstrate they are a leader by showing their leadership skills through their involvement in school or in the community. APCA received 802 applications from students throughout the United States. Each submission was reviewed by a panel of 137 judges and tabulated. The top 28 students each received \$2,000 scholarships from the National Scholarship Program. The next tier of students were sent to the local Chapters, who awarded an additional \$100,400 in scholarships to an additional 86 students. APCA works with local high school counselors to help distribute the information about the scholarship program to all students; we are proud to be able to distribute the grants to students based on their accomplishments regardless of their race.

Local Chapters host a mixture of events to help raise funds for the high school scholarship program listed above and community programs. Events include dinners and mixers where we provide networking opportunities for our employees, educational seminars where we invite guest speakers, cultural events during special holidays such as Lunar New Year or Asian Heritage Month to encourage cultural enrichment of Asian and non-Asian employees, Dragon Board Races to expose employees to the cultural activity while practicing teamwork, Lunch & Learn sessions on self-development topics, Health and Wellness fairs to educate members and employees about health-related matters, silent auctions, and sales of tee-shirts and cookbooks. The Chapters also coordinate back-pack drives, toy drives, and food baskets for needy families.

4c (Code: ) (Expenses \$ 23,333 including grants of \$ 12,000 ) (Revenue \$ 13,748 )  
Ten of the 15 APCA Chapters participated in Dragon Boat Races in their local community. This activity is very popular because it allows us to educate Asians and non-Asians about the Dragon Boat culture while encouraging our members to exercise and practice as a team. Each team consists of 20 paddlers, a drummer to provide the paddling tempo, and the steersman who provides the team with guidance of steer the boat. The team who crosses the finish line first wins the race and trophy. In many communities, the boat race is actually a fundraiser for the Dragon Boat Association or a community non-profit organization. APCA has been fortunate enough to have AT&T sponsor half of the Dragon Boat events; AT&T uses the events for Marketing purposes and allows APCA teams to use the boats for the race.
