FOOD SECURITY PCI takes a comprehensive approach to improving health outcomes by integrating its food security programs with nutrition, health, agricultural development, food aid, and disaster risk management interventions. PCI has implemented 20 USAID Title II food assistance projects since 1997, and is currently implementing projects in Malawi and Guatemala. Through the Njira program in Malawi, PCI is working to build pathways to sustainable food security in the Balaka and Machinga districts. PCI has overall responsibility for Njira's program management, technical leadership, implementation, project monitoring and evaluation, coordination with partner organizations, commodity management, and reporting to USAID. As an implementing partner on the USAID-funded PAISANO program in Guatemala, PCI is leading all project interventions in five of the project's 13 target municipalities, managing distribution of over one-third of the project's commodities, and spearheading the project's cross-cutting goal to improve the status of women. In Guatemala, the USAID-funded ACCION project is reducing hunger and improving nutrition for over 2,700 families through food distribution and vouchers. The program also links public health services to the community, and has reached over 7,000 people through health and nutrition fairs. Through funding from USDA, PCI has designed and implemented an additional 25 food aid projects in Tanzania, Indonesia, Bolivia, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, and the Central American region. PCI is currently implementing three USDA food programs in Tanzania, Guatemala, and Nicaragua. Through USDA-funded school-based food security programs in Nicaragua, Guatemala and Tanzania, over 220,000 students received a hot, nutritious meal daily in 2016.

HUMANITARIAN ASSISTANCE PCI currently operates disaster risk reduction and humanitarian assistance programs in several countries across Africa, Asia and the Americas. PCI provides humanitarian assistance to people affected by disasters and complex emergencies, helps governments, local organizations, and communities better manage risk and respond to emergencies when they arise, and integrates efforts to help reduce vulnerability to disasters into all of its ongoing programs. In Ethiopia, pastoralist families utilized geoclimatic satellite data for decision-making on where to locate good grazing land to reduce livestock deaths. PCI's interventions led to a 47% drop in herd mortality in vulnerable communities representing \$8.4 million dollars in livestock surviving compared to average annual losses experienced in the previous three years. PCI estimates that \$5.4 million (64% of the value in reduced losses) can be attributed to PCI's interventions. This innovative method is staged to scale across Ethiopia, Kenya and Tanzania, where it will help the largest populations of pastoralists improve their livelihoods. Through USAID's REVIVE project in Ethiopia, PCI is increasing vulnerable communities' long-term resiliency to climate-change and climate-related shocks by improving Disaster Risk Reduction decision making, improving household adaptability, and enhancing community planning and processes, which will serve 620,000 people. Under the USAID-funded Barrio Mio Project in Guatemala, PCI is transforming an urban neighborhood by reducing its risk of disaster, strengthening the capacity of its municipal government to manage growth, improving water and sanitation infrastructure, and developing the economic assets of its most vulnerable households. Under Barrio Mio, PCI has reached over 150,000 beneficiaries, upgraded 94 communities, trained over 6,000 people, and engaged with over 40 local partners.
