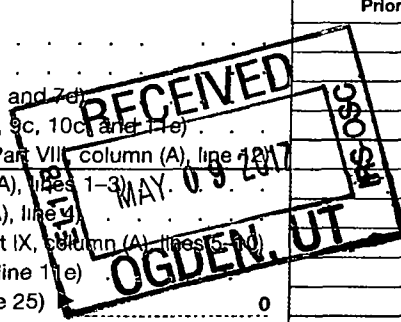

In addition, the four voting Trustees serving on the Board of the Institute also constituted the majority of the Institute's Executive Committee and of the Institute's Compensation Committee during the tax year.
