There were 4,075 participants from 97 countries and territories taking part in the Center activities throughout the region. While more information on the Center and its programs may be found at our website (www.EastWestCenter.org), the following is a highlight of the program activities during the year:</p> <p>SEMINARS AND OUTREACH PROGRAMS The Center has developed the most extensive program of trans-Pacific journalist and editor exchanges in the region, with exchanges for the Asia Pacific region as a whole (Jefferson Fellows). The Changing Faces women leadership seminar discusses and celebrates women's entrepreneurship. The Center also offers short-term policy seminars where senior and emerging leaders and business people from a variety of sectors focus on issues of regional concern. These programs are developed around a thematic focus and provides participants with an opportunity to strengthen their understanding of Asia Pacific-U S developments and challenges, build a regional network and to become leaders with a more international perspective. In September, some 350 international journalists and media professionals from more than 40 countries met in India's capital for the EWC's 5th International Media Conference, on the theme of "South Asia Looking East" that included keynote speakers such as the Indian Foreign Secretary S. Jaishankar and Nobel Peace laureate Kailash Satyarthi.</p> <p>East-West Center in Washington supports the Center's mission through direct work with U S policymakers and opinion leaders in the nation's capital. It facilitates understanding of the U S policy process by its Asia Pacific participants through direct interaction with U S policymakers. It also continues the successful Asia Matters for America/America Matters for Asia initiative to organize and disseminate information, data, and analysis on U S - Asia interactions. The Center also launched a new Congressional Staff Program on Asia to equip staffers with a greater knowledge of U S - Asia policy. Ten competitively selected staff members from both houses and political parties participated in the weekly seminar program.</p>

EDUCATION PROGRAM The Center is at the forefront of educating people of the Asia Pacific region to meet the evolving demands of global change. The Education Program focuses on community building at the campus level as a stepping-stone to community building at the regional level. The participant's experience is one of grassroots relationship building, cultural exchange, shared experiences, and communal preparation for future leadership roles throughout the region. The Program offers educational opportunities for future leaders in the Asia Pacific region and the U.S. in an era of increased social, economic and technological interdependence. Graduate degree scholarships and certificate programs prepare students and professionals to address the challenges and complexities of the world's most dynamic region. Undergraduate degree scholarships build and strengthen the base of future leaders in the South Pacific. The Program also provided professional development programs for educators to strengthen the capacity of individuals and institutions to cultivate in their students an appreciation and understanding of the histories, cultures, and contemporary issues of the Asia Pacific. The Program accomplishments include continued training of future leaders in the Southeast Asia Youth Leadership Program, Asia Pacific Leadership Program (APLP), and college and K-12 educators through the AsiaPacificEd Program and the Asian Studies Development Program (ASDP). ASDP celebrated its 25th year of working to enhance undergraduate-level teaching about Asia at American colleges and universities. Since 1991, more than 2,300 educators from virtually every U.S. state and 26 foreign countries have participated in ASDP curriculum development workshops across the U.S. and abroad. Other continuing programs are the Pacific Islands Women in Leadership, Study of the U.S. Institutes (SUSI) for Student Leaders on Global Environmental Issues, and the Brunei-U.S. English Language Enrichment Program for ASEAN aimed at raising the level of English language skills in the region. In FY 2016, 410 students from 51 countries and territories participated in the Center's undergraduate and graduate training and scholarship program that is unlike individual scholarship programs, since these students are instilled with a common learning experience centered on U.S.-Asia Pacific issues and community service.
