Humanities to Go brings neighbors together for learning and thoughtful conversation while connecting NH residents to our states rich historical and cultural resources. The Humanities to Go speakers bureau includes 200 different high-quality lectures and living history presentations by 100 different NH scholars. This deceptively simple program offers a lifeline to cash-strapped local organizations that could not afford to create or pay for such programs on their own. In 2016, Humanities to Go partnered with 240 local host organizations in 147 NH communities to sponsor 357 programs attended by more than 12,299 people.

In 2016, New Hampshire Humanities offered two special initiatives. 1. Cant Take a Joke: The Transformative and Incendiary Power of Editorial Cartoons. Over 1,000 high school students and teachers met met Pulitzer Prize-winning editorial cartoonists and authors at the annual HYPE Conference. Students led their peers in conversations about contemporary challenges to the freedom of expression in the US and around the globe. The Pulitzer panel also spoke at an evening event attended by 228 people and appeared on NH Public Radios The Exchange. A documentary about HYPE was created and distributed nationally. 2. From Troy to Baghdad: Dialogues on the Experience of War and Homecoming recognizes the power of storytelling and dialogue to address the experience of war and the challenges soldiers face when they return home by bringing team-facilitated discussions of Homers Odyssey plus contemporary texts to groups of veterans. Veterans are both the subjects and authors of this program, assuming a leadership role in shaping the syllabus, facilitating the groups, and evaluating the work.

Community Project Grants enable NH Humanities to be responsive to the ideas and interests of NH residents. Grant-funded projects in FY 2016 included an exhibition of Shakespeares First Folio and related talks and dramatizations, an exhibit and teacher professional development about our states Francophone history, talks and a festival celebrating a towns musical heritage in order to spur entrepreneurship and innovation, bridging the divide between military veterans and civilians through a region-wide community read project featuring Tim OBrenns The Things They Carried and over 50 related events and conversations on agriculture and climate change, poverty and income disparity, and the perseverance of human spirit based on a region-wide community read of Steinbecks The Grapes of Wrath. In 2016, the NH Humanities Board of Directors, through its Program Committee, approved 17 competitive grants totalling 44,907 matched by approximately 130,480 of cash and in-kind community support.
