THE RHODE ISLAND COUNCIL FOR THE HUMANITIES (THE COUNCIL) MARKED SEVERAL SIGNIFICANT ACCOMPLISHMENTS DURING THE 2016 FISCAL YEAR, CONTINUING TO GROW AS AN INNOVATIVE, COLLABORATIVE ORGANIZATION SUPPORTING PEOPLE AND PROJECTS ACROSS RHODE ISLAND AND DEVELOPING WAYS TO MAKE THE HUMANITIES MORE AVAILABLE AND MORE POWERFUL FOR ALL THE COUNCIL'S GRANTMAKING PROGRAM AMPLIFIED VOICES AND STORIES THAT NEED TO BE TOLD AND HEARD, AWARDING APPROXIMATELY \$166,452 TO 36 GRANT PROJECTS ACROSS THE STATE THESE INVESTMENTS LEVERAGED MORE THAN \$890,375 IN ADDITIONAL SOURCES OF FUNDING FOR THE COUNCIL'S GRANTEEES PROJECTS FOCUSED ON A BROAD RANGE OF TOPICS THAT SPEAK TO OUR STATE'S PUBLIC HISTORY, CULTURAL HERITAGE, CIVIC EDUCATION, AND COMMUNITY ENGAGEMENT THE COUNCIL ALSO MARKED THE 100TH ANNIVERSARY OF THE PULITZER PRIZES WITH OUR WHAT IS THE 21ST CENTURY ESSAY?
