Since its inception in 1991, the Foundation has raised over \$135 million for renovation of and improvements to the Iowa State Fairgrounds.

Ruan Plaza - a pedestrian friendly plaza being constructed to connect the Grand Concourse with the Jacobson Exhibition Center.
It features a boulevard area with improved utilities and access for exhibitors and vendors, it is framed by 20 foot wide walkways.
In 2016 the second phase paved the gravel parking areas and added trees and a dedicated sidewalk for better pedestrian flow.

Youth Inn - started its renovation phase with roof replacement and cooling of the upper level. More renovations included
extended walkways that will lead fairgoers to new entrances on the north and south sides of the building. Updated fire alarm and
suppression systems and handicap accessibility to all levels of the building with new elevators. The final phase in fiscal year
2016 saw windows replaced and improvements to the main floor and stage area. In addition the kitchen facility was enhanced.
New landscaping and a parking lot completed the north side of the building.
