Provided schooling for more than 8,000 children grades K through 12. Provided college scholarships to 140 students. Managed 8 schools and partnered with more than 50 other schools. 90 vulnerable women gained a marketable skill through vocational training, there have been 545 total past graduates. Sponsors gave gifts to children and their families through the online store. The Africa College of Theology enrolled 190 students. There have been 27 past graduates and approximately 2,000 people have trained through ACT programs and classes. Thousands of children and community members were seen by six resident community nurses and visiting US medical teams. Construction of the Dream Medical Center continued with an expected opening date of Summer 2017. This mini-hospital will include 45 beds, 2 operating rooms, a delivery ward, physical therapy, rehabilitation, maternal and child services. More than 1.2 million meals were provided for students and their families. More than 300 US visitors spent time with their sponsored children and served in different capacities in our sponsored communities.
