For MOS client - a care plan and budget is developed that supports their physical, emotional and social well-being. The amount of support clients receive is determined by their needs. As needs change, so does the amount of support. Following are the MOS procedures. Clients become financial client of the MOS program when they do not have enough income to sustain their daily cost of living, which is "need based and they do not have more that \$2,000 in liquid assets. If they own a home, MH takes over the deed of their property or ownership of policies (life insurance, etc). The application for financial assistance is initially approved by the Admissions Committee. Each year the client goes through a recertification process in which they need to produce new bank statements, financial records, etc and their budget is verified. The case manager recommends any changes to the budget to the MOS Manager. The Manager then forwards to the Director for final approval. Every budget increase/decrease is reported in a summary report to the full Board of Trustees on a quarterly basis. The original documentation that includes bank statements, budget calculations, receipts are kept in the client file. All changes to the budget are substantiated with back-up documentation (e.g., documents showing rent increases, etc). Each year the client produces new documentation during their recertification process. The client's monthly budget and care plans are reviewed each month by the Manager and the Director of the program.
