In evaluating the collectability of accounts receivable, the Hospital analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowance for doubtful accounts and provision for bad debts. The difference between the standard rates (or the discounted rates if negotiated) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts. Management regularly reviews data about these major payor sources of revenue in evaluating the sufficiency of the allowance for doubtful accounts. The Hospital's allowance for doubtful accounts for self-pay patients was 90.0 percent of self-pay accounts receivable at both October 31, 2016 and 2015. In addition, the Hospital's write-offs totaled approximately \$1,708,000 and \$2,554,000 for the years ended October 31, 2016 and 2015, respectively. Decreased write-offs were the result of a lower number of self-pay accounts primarily related to the Affordable Care Act (ACA) and Medicaid expansion, resulting in less uninsured patients. The Hospital maintained allowances for doubtful accounts from third-party payors of approximately \$3,636,000 and \$4,719,000 as of October 31, 2016 and 2015, respectively. The Hospital has not changed its charity care or uninsured discount policies during the years ended October 31, 2016 or 2015.

Over 1,200 pieces of fresh produce were distributed to attendees plus each attendee was offered a healthy luncheon meal. During the community health fair, there was a health cooking demonstration from the hospital's Dietary Director. Presentations were offered on diabetes awareness and the signs and prevention of stroke. VPH also participated in the Children's Community School Fair, Los Angeles Valley College Health Fair, Latino Expo, Successful Aging Expo, and Health Screenings at Curacao at the Panorama Mall.
