THE DODGE COUNTY FAIR ASSOCIATION IS A STATE OF WISCONSIN CORPORATION FORMED FOR THE PURPOSE OF OPERATING THE FAIRGROUNDS, INCLUDING ORGANIZING AND OPERATING THE ANNUAL COUNTY FAIR. THE FAIRGROUND IS PRESENTLY LOCATED THREE MILES EAST OF THE CITY OF BEAVER DAM ON 40 ACRES OF LAND OWNED BY THE CORPORATION. THE 2016 DODGE COUNTY FAIR EVENT WAS HELD FROM AUGUST 17TH THROUGH AUGUST 21ST. THE COUNTY FAIR AND MUSIC FESTIVAL CURRENTLY ENTERTAINS 50,000 PLUS FANS EACH YEAR. THE OUTDOOR MAIN STAGE CONCERT VENUE, INCLUDED IN THE PRICE OF ADMISSION TO THE FAIR, INCLUDED NATIONAL MUSICAL ACTS OF MONTGOMERY GENTRY, GRANGER SMITH, BRET MICHAELS, AND CANAAN SMITH. OTHER ENTERTAINMENT THROUGHOUT THE FAIRGROUNDS INCLUDED SMALL STAGE MUSICAL ACTS AND SHOWS, FARM ANIMALS AND EXHIBITS FOR VIEWING, A CARNIVAL WHICH INCLUDED RIDES AND GAMES ON THE MIDWAY, AND FOOD AND BEVERAGE CONCESSIONS. THE FINAL DAY OF THE FAIR IS HIGHLIGHTED BY THE ALWAYS POPULAR DEMOLITION DERBY.
