GREEN MOUNT CEMETERY'S WRITTEN CONFLICT OF INTEREST POLICY STATES THAT IT SHALL GENERALLY AVOID BUSINESS RELATIONSHIPS THAT GIVE RISE TO CONFLICTS OF INTEREST EXCEPT WHERE THE BOARD HAS DETERMINED THAT SUCH A RELATIONSHIP WILL RESULT IN SUPERIOR SERVICES BEING RENDERED TO GREEN MOUNT.
