Energy and Weatherization Assistance-Provides low income families with help paying utility bills, home weatherization to conserve energy and education to help reduce energy burden. The program weatherized 393 units and provided 6,392 households with energy assistance in 2016.

4b (Code) (Expenses \$ 5,925,374 including grants of \$) (Revenue \$)

Education-Services provided through Head Start program for childcare, education and support services for children ages 0 to 5. The program assists in the total development of the child through health, nutrition, education and parent involvement. The program served 419 pre-kindergarten age children in its Head Start program, 104 infants and toddlers in its Early Head Start program and an additional 214 children in partnerships with Independent School Districts in 2016.

Other Client Assistance-Various programs to provide social services to low income individuals and families. Services provided include a literacy program, prescription assistance and operation of 10 unit low income housing. 104 students were enrolled to work toward obtaining their GED in Project Turn-Around classes in 2016. The school supply drive "Supply Our Schools" provided school supplies for low income students in all Nacogdoches County public schools.
