A full board of directors consists of eleven elected members. The newly seated board each year meets on the first Monday following the annual meeting and elects from its own the officers. Officers serve for a one year term and include president, vice president, secretary, and treasurer. Likewise a finance committee is established to provide monthly and annual financial statements to the board of directors, pay bills on a timely basis, and file tax returns. Board members meet at least monthly, presently on the first Monday of each month. Directors and officers of the board act on behalf of the membership to operate the club including contracts and services.
