APPLICANTS ARE CAREFULLY REVIEWED AND REFINED BY THREE VOLUNTEER COMMITTEES, AN OVERSIGHT COMMITTEE, AND THE BOARD OF DIRECTORS PRIOR TO FUNDS BEING APPROVED AND DISTRIBUTED. FUNDS ARE THEN DISTRIBUTED TO PARTNER AGENCIES BASED ON THESE ASSESSEMENTS TO PROVIDE THE GREATEST IMPACT POSSIBLE IN THE COMMUNITY. UNITED WAY OF ANDROSCOGGIN COUNTY (UWAC) PARTICIPATES IN SEVERAL OTHER PROGRAMS TO BENEFIT THE COMMUNITY AS FOLLOWS: *2-1-1 A STATE-WIDE INFORMATION AND REFERRAL SERVICE THAT CONTINUES TO RECEIVE CALLS REGARDING HEATING AND UTILITY ASSISTANCE, FOOD, HOUSING AND FINANCIAL SERVICES, ALONG WITH HEALTH AND HUMAN SERVICE INFORMATION. IN 2016, 52,810 CALLS WERE RECEIVED STATE-WIDE AND 4,255 CALLS WERE FROM LOCAL RESIDENTS. *CASH THE EARNED INCOME TAX CREDIT BENEFITS PEOPLE WHO WORK. UWAC, TOGETHER WITH PARTNERS IN THE LEWISTON-AUBURN CASH COALITION, WORK TO MARKET THIS PROGRAM TO HELP LOW-TO-MODERATE INCOME WORKERS. *BACKPACK PROJECT UWAC, IN PARTNERSHIP WITH LOCAL CIVIC CLUBS AND AREA BUSINESSES, PROVIDED OVER 400 BACKPACKS THAT WERE FILLED WITH SCHOOL SUPPLIES TO HELP KIDS START OFF THE YEAR WITH THE RIGHT SUPPLIES. *TOUCH-A-TRUCK EVENT UWAC AND AREA PARTNERS HOST A COMMUNITY EVENT IN WHICH CHILDREN AND FAMILIES HAVE AN OPPORTUNITY TO SEE, TOUCH, AND INTERACT WITH DOZENS OF VEHICLES INCLUDING POLICE CRUISERS, CONSTRUCTION EQUIPMENT, RACE CARS, TRACTOR TRAILERS, AND FIRE TRUCKS. A BOOK SWAP AND OTHER AGE APPROPRIATE LEARNING ACTIVITIES ARE AVAILABLE, TOO. *10 YEAR PLAN TO END HOMELESSNESS IN THE LAST COUPLE YEARS MUCH PROGRESS HAS BEEN MADE, INCLUDING PRESENTATIONS TO AREA CIVIC CLUBS, DEVELOPMENT OF 80 NEW UNITS AND MORE HOUSING OPPORTUNITIES FOR VETERANS. *DAY OF CARING IN 2016, UWAC ORGANIZED ITS ANNUAL DAY OF CARING WHICH BROUGHT TOGETHER COMMUNITY MEMBERS TO VOLUNTEER AT VARIOUS PROJECTS. THIS EVENT DREW 240 VOLUNTEERS WHO WORKED ON 36 PROJECTS. *FAMILYWIZE UWAC IS A PART OF THE FAMILYWIZE COMMUNITY SERVICE PARTNERSHIP TO DISTRIBUTE FREE PRESCRIPTION DISCOUNT CARDS THAT CAN SAVE INDIVIDUALS UP TO 30% ON THEIR PRESCRIPTIONS. *PANTRY PROJECT THE PANTRY PROJECT BRINGS TOGETHER FOOD COLLECTION EFFORTS OF EMPLOYEES AT LOCAL BUSINESSES TO HELP MEET THE NEEDS OF PEOPLE THAT ARE HUNGRY. UWAC PARTNERS WITH 17 FOOD PANTRIES AND THE GOOD SHEPHERD FOOD BANK TO DISTRIBUTE NON-PERISHABLE ITEMS. *BRIDGES OUT OF POVERTY UWAC SPONSORED A COMMUNITY-WIDE TRAINING ON BRIDGES OUT OF POVERTY.
