Support for Park Activities: Funded and arranged for production of ten new terrain models for Baxter State Park, to be installed at Ranger Stations, Visitor Center, and Park Headquarters, as well as for use in educational programs. These new terrain models, to be installed in summer 2017, will help visitors plan their trips, understand the terrain they are exploring, and have more safe and enjoyable visits to Baxter State Park. We began planning in 2016 to launch a new Baxter Youth Conservation Corps in 2017. Two adult leaders and ten youth (all paid positions) will work for two weeks in July 2017 on trail maintenance projects, for a total of 960 hours of trail services donated to Baxter State Park.

Education and Outreach: We fund and administer the Maine Youth Wilderness Leadership Program, which enables 10 high school students to experience a 9-day wilderness program, learning from specialists in science, art, storytelling, writing, history, and recreation. Our goal is to cultivate and inspire the next generation of wilderness leaders. Other Education and Outreach activities include our quarterly newsletter (4,800 copies distributed annually); publication and distribution of the annual Baxter State Park calendar; eight trips to Baxter State Park for a total of 63 people; educational talks and displays at four public fairs and events; hosting three book-release events for the publication of Plants of Baxter State Park (we provided the funding in 2014 and 2015 for the publication of this book); and hosting two Speaker Series events.

Advocacy for the Park: Attended all meetings of the Baxter State Park Authority, all meetings of the Baxter Park Wilderness Fund, nine meetings of the Appalachian Trail Task Force, and two public listening sessions on the proposed Katahdin Woods and Waters National Monument; gave presentations about the Park to four organizations; and funded distribution of brochures and outreach materials through the Maine Tourism Association
