OVER 4,000 EDUCATORS AND 150,000 STUDENTS USED THESE MATERIALS FOR EDUCATIONAL PURPOSES. MATERIALS ARE SOLD AT A NOMINAL COST OR PROVIDED FREE TO THE TEACHERS THROUGH OUR WAREHOUSE WHICH IS OPEN 35 HOURS PER WEEK. A TOTAL OF 206 VOLUNTEERS WORKED 12,808 HOURS IN PROVIDING SERVICES TO OUR MEMBERS. THE EXPENSES FOR OUR SERVICES REFLECT PAYROLL, TRUCK EXPENSES (GAS & INSURANCE) AND FACILITY EXPENSES. IN ADDITION, TREASURES 4 TEACHERS PARTICIPATES IN THE KIDS IN NEED FOUNDATION'S SCHOOL SUPPLY DISTRIBUTION PROGRAM. DURING 2016, TREASURES 4 TEACHERS RECEIVED SCHOOL SUPPLIES VALUED AT MORE THAN \$2.5 MILLION FROM KIDS IN NEED FOUNDATION TO BE DISTRIBUTED AT NO CHARGE TO MEMBERS FOR USE IN LOCAL SCHOOLS.
