For 2015 we had a public support percentage of 32.65%, less than a percent off of the required amount. The Calumet Education Foundation maintains appeal mailings. Benefit dinners open to the general public are held in support of the Foundation. Board members continually reach out to members of the broad community including seeking support and building relationships. Revenues come from individual contributions, bequests, and fundraising events open to the general public. Currently we have 17 unique named scholarships aimed at providing support to a broad base of students. Grants are aimed towards all students seeking higher education in our community. These grant and scholarships are distributed annually. Trustees of the foundation provide representation from a diverse sample of our community and include teachers, parents, lawyers, politicians, accountants, bankers, business owners, realtors, financial advisors, and retirees.
