LAND CONSERVATION 2016 was one of SELT's most successful years in land conservation to date, bringing the organization's cumulative impact to more than 16,000 acres. All eleven projects completed in 2016 were through conservation easements and all were completed in partnership with private, municipal, state, and federal partners. SELT's conservation work focused on three key areas: Living Landscapes, Farmland for the Future, and Clean Drinking Water. Under our Living Landscapes initiative, SELT seeks to conserve large landscapes critical due to their abundant natural resources, water quality, ecological integrity, wildlife habitat, and recreational opportunities. This includes the vision of Pawtuckaway to Great Bay Greenway, seeking to link multiple conservation focus areas into a corridor. SELT completed three projects in this Greenway, including the 1,131 acre Harveys' Kennard Hill Forest in Epping & Nottingham, the abutting Sweetser Farm in Nottingham, and the Limpens Farm on the banks of the Lamprey River in Epping, Newfields, and Newmarket. EASEMENT STEWARDSHIP: For the 9th year running, SELT monitored 100% of its 170 conservation easements to ensure continued protection of the natural resources of these conserved lands. We also worked with our partners to support their monitoring of the 44 easements which we hold the executory interest on (back up to the primary easement holder). Finally, we contracted with municipalities to monitor 24 town conserved lands. SELT completes this work through two full time and one seasonal staff member complemented by our effective Volunteer Easement Monitor Program. Monitoring is completed by a combination of aerial photograph interpretation and on the ground site visits. In 2016, SELT integrated tablets into our field work, greatly improving our accuracy and efficiency in data and image collection. Stewardship is more than monitoring and enforcement and SELT continues to seek ways to build cooperative relationships with our original and successor landowners. To this end, SELT produced an Easement Stewardship Guide for Landowners, to help guide. CONTINUED ON SCHEDULE O

LAND MANAGEMENT: While SELT's land ownership did not grow in 2016, SELT focused on improving public access and wildlife habitat on our existing 3,600+ acres. A committed group of volunteers provided critical support to implement trail improvements, including the installation of kiosks, signage, and trail markers at the Powwow River Woodlands in South Hampton, the Kimball Reserve in Exeter, and the Rand Memorial Forest in North Hampton and Rye. Work days were hosted with employees of Timberland and VapoTherm, and Philips Exeter Academy students, greatly advancing trail improvements at the Mast Road Natural Area in Epping and invasive plant removal along the Pawtuckaway River. At SELT's Burley Farms, after consultation with wildlife biologist, SELT restored young forest habitat along the 40 acre beaver pond to create habitat diversity. Additional work at the Burley Farms included the restoration of the farm fields through invasive plant removal and the planning for a public trail system.

Farmland for the Future initiative, a strategic effort to protect working farms and land with

productive soils that can be farmed. SELT conserved three additional farms, including the

Monahan Farm, a pick-your-own paradise in East Kingston, the first phase of the Bodwell Farm

in Kensington – one of just five commercial dairy farms left in Rockingham County, and the Ten

Rod Farm in Rochester, allowing the new landowner to revitalize the farm. Five projects

advanced our efforts to protect lands for Clean Drinking Water. These included two along the

Lamprey River, the Thompson Forest in Durham and a donated easement on the Meeker property in

Lee. The Thompson Forest abuts the public water intake for the Durham and University of New

Hampshire water supply. In the western edges of our service area, SELT partnered with the

Towns of Derry to conserve the Buttonwood Farm on Ballard Pond and with the Town of Auburn to

purchase easements on the Dufresne and Rolfe lands, both within the water supply protection

area for Lake Massabesic, the public supply for Manchester. In addition to completing these

projects, by year's end SELT had executed 14 additional contracts to conserve 3,000+ acres of

land by the end of 2018.
