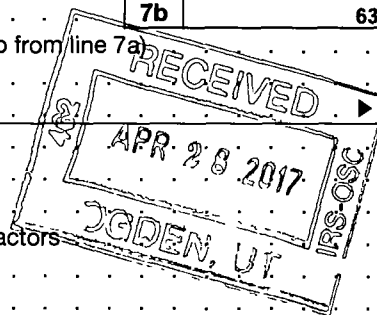

NH Peace Action Education Fund's top program accomplishments in 2016 was public education, one major conference, sponsorship of over 20 and co-sponsorship of many more public events. At these events, films, speakers and discussion forums were the primary medium for this public education work, but earned media through the final weeks of the 2016 NH Presidential Primaries, and radio and public access TV were also used to educate the public on peace issues. Pubic education was also done through our list server and newsletter, as well as articles by staff and board members in online foreign policy publications. Organizing of skills training focused on empowering young people to make change in their world was a secondary priority, and several meetings with Concord High School students concerned with racism and hate in their school were precipitated by an overnight skills-building youth retreat in September. Given the

high levels of violence at rallies where then-Republican-nominee Trump was speaking, NH Peace Action also organized clergy and

other trained peacekeepers to de-escalate high-conflict situations should they arise when the candidate came to New Hampshire.

While we only did this a few times, it was our third program area.
