Housing and supportive services are provided to individuals and families who are homeless or at risk of becoming homeless. Directly owned properties at Spruce Street, Amherst Street, Lake Ave and Douglas Street served 268 individuals, 217 of those received emergency housing at the Lake Ave facility. Other indirectly owned properties in Concord, Manchester and Dover served 425 individuals. An additional 47 individuals living in the community received supportive services and rental assistance.
