We empower the local church to break the cycle of poverty in the poorest and most marginalized communities in the world. Poverty is a very complex issue, nearly always affecting the spiritual, social and material realms of a community. Our transformational development model builds on the biblical truth that the Gospel should bring wholistic transformation to the whole person. The Local ChurchIn 2016 we partnered with 176 local churches within the 14 countries we serve in Africa and the Caribbean, 69 of which were new church partners. A total of 66,328 people were served throughout the various communities by mobilizing the local church and equipping them to address the needs of their communities Social Engagement/OVCA total of 3,800 individuals were served through our Social Engagement Program initiatives including 3,152 children in our Orphans and Vulnerable Children program and 648 guardians, who were economically empowered to support and care for the children Community HealthA total of 45,084 individuals were served and/or trained through our Community Health Program initiatives including, 8,008 Health Education & Training, 24,253 Medical Provision, 4,530 Water Sanitation and Health, 48 Antenatal Care, 2,908 Family Planning, and 5,337 HIV/AIDS prevention and care EducationA total of 5,869 individuals were served through our Education Program initiatives including 1,121 Early Childhood Development, 4,594 Primary and 154 Adult Literacy A total of 891 local leaders were empowered and equipped in our wholistic training including 200 Training of Trainers (TOT), 426 Community Health Evangelists (CHE) and 265 Community Committees (CC) Economic EmpowermentA total of 2,651 individuals were served through out Economic Empowerment Program initiatives including 944 Micro Enterprise Training, 668 Loan Service, 453 Skill Training and 586 Income Generating Activities LIA expanded into two new countries Rwanda and DR Congo. We also saw the completion of the first two phases of a training center in Nairobi and the graduation of the first three classes from this facility. LIA also hosted for the third time, the annual global missions health conference in Nairobi, this time including a preconference training for doctors as well as a post conference for church and development workers. This conference has now gained accreditation by the medical board to provide continuing education credits
