THE FUND CAN COVER A VAST NUMBER OF REQUESTS RANGING FROM SUBSIDIES FOR TRUST CREATION COSTS, FUNERAL AND BURIAL COSTS, FINANCIAL LITERACY COURSES, VOCATIONAL SUPPORT, ASSISTIVE DEVICES, TRANSPORTATION, AND OTHER EMERGENCIES.
