At Planned Parenthood of Northern New England (PPNNE), our work is guided by our mission to provide, promote, and protect access to reproductive health care and sexuality education so that all people can make voluntary choices about their reproductive and sexual health. Women, men and teens across Maine, New Hampshire, and Vermont rely on PPNNE as an affordable reproductive and sexual health care provider, educator, and steadfast advocate. In 2016, patients came to our 21 health centers across the region for vital services, such as well woman exams, cancer screenings, a wide array of effective contraceptive methods, emergency contraception, abortion care, sexually transmitted infection (STI) testing and treatment, confidential HIV testing and counseling, colposcopy (a follow-up procedure for abnormal Pap tests), immunizations, and other care. PPNNE continues to serve as a major safety-net provider - and for many of our patients - their primary source of health care. In 2016, 69% of our patients were living at or below 200% of the federal poverty guideline (\$23,760 for one person), 44% were living below 100% poverty (\$11,880 for one person), 20% were uninsured/self-pay and another 34% had coverage through Medicaid or another public program. Our patient base was also overwhelmingly female (87%) and young. In 2016, 16% of our patients were teens and 70% were under the age of 30. Especially at our urban sites, we are serving increasing numbers of New Americans, in 2016 patients spoke more than 28 languages. Highlights of our 2016 work include - Providing reproductive and sexual health care to 41,956 patients through 62,316 visits, a 7% and 8% increase, respectively, over the prior year - Delivering \$8.1 million in free/discounted health care through our sliding fee scale program - Providing vital services including 76,465 STI tests, 12,899 pregnancy tests, 6,183 breast exams, 4,752 Pap tests, and 6,204 insertions of long-acting reversible contraceptives (IUDs and implants, which are highly effective and strongly recommended methods) - Achieving high patient satisfaction ratings. In a recent patient survey, 99% of patients rated their experience as "excellent or "good." Also, 99% of patients said they would recommend PPNNE to others. Through word-of-mouth referrals as well as targeted patient outreach /marketing, PPNNE successfully reached more underserved people. In 2016, over 17,900 of our patients were new or hadn't received care at PPNNE in the past three years - Significantly enhancing PPNNE's role as an inclusive health care provider for LGBTQ+ patients. In particular, in 2016 health center staff participated in trainings to improve and expand transgender services in all of our health centers. All health center staff have been trained in making our health centers trans-friendly and all clinicians have been trained to provide transgender hormone therapy - Continuing to implement facility renovations/relocations, which increase health center capacity, create positive, welcoming environments for patients, and contribute to improved long-term sustainability. Work in 2016 included refurbishing the Derry, NH health center, relocating our Biddeford, ME health center to a larger, well-designed & rebranded new site, relocating our Rutland, VT health center to a larger and fully renovated new site, making progress on the major redesign of our flagship NH health center in Manchester, and laying groundwork and scouting potential locations for future health center projects - Guided by an overarching goal to reduce unintended pregnancy in northern New England, PPNNE made further strides (as capacity allowed) on other special initiatives and strategies-often involving creating new or strengthened partnerships and enhancing access to contraception, especially long-acting reversible contraceptives (LARC).

4b (Code) (Expenses \$ 135,195 including grants of \$) (Revenue \$)

In 2016, PPNNE continued to reach and engage young people and supporters through intern programs, greeter programs, community tabling, educational events, and other outreach. Additionally, PPNNE's education programming strives to ensure young people have access to the health information they need. To be effective, we believe teens must play an instrumental role in designing and implementing PPNNE's community education initiatives. As such, our Peer Education Program trains youth to serve as peer educators, delivering life-changing sexuality education in schools, community groups and through one-on-one interactions. Student participants receive extensive training and continuous support from our staff. In 2016, our Vermont Peer Educators conducted over 3,600 conversations with peers who had sexual health-related questions or concerns, and participated in 31 educational/outreach events. Last fall, PPNNE began our first peer education program in the state of New Hampshire. PPNNE is partnering with a public charter school in Manchester - a high need area and the most populous and diverse city in the state. During the fall semester, the three students in our first cohort of Manchester peer educators completed their 40 hours of training and began conducting outreach at their school. In total, PPNNE had 21 teens serve as peer educators in 2016 - 18 in Vermont and 3 in New Hampshire. This innovative program is continuing in 2017, with goals to further increase the number of peer educators and the impact of their activities on local youth. And, across PPNNE's health center communities in all three states, our staff continued to conduct many outreach activities to deepen referral relationships with other organizations that serve low income or young people, raise visibility, and bring services and education to more underserved, at-risk women and teens. Among the many positive impacts, this work has contributed to continued growth in the number of women coming to our health centers seeking highly effective contraceptive options that PPNNE expertly provides.

4c (Code) (Expenses \$ 1,120,519 including grants of \$) (Revenue \$)

In 2016, PPNNE's public policy and grassroots organizing staff worked to promote and protect access to women's health care, the needs of uninsured and low income populations, and reproductive rights. Supporting their work is a network of hundreds of activists throughout Maine, New Hampshire, and Vermont who help us face challenges unique to our political landscape. Across our region, we utilize staffing, volunteer, and advocacy strategies designed to optimize each state's strengths and overcome specific threats and challenges, including protecting women's health care and family planning access. Examples of this work in 2016 include - Defeating numerous anti-choice, anti-family planning bills in New Hampshire - protecting access to women's health services - Achieving a major proactive policy win in Vermont last year, one that takes on special importance in light of current efforts to repeal the Affordable Care Act (ACA). In May 2016, the Governor signed into law the most comprehensive birth control access bill in the country, which codified the ACA's birth control benefit for Vermonters. This means that if the ACA is repealed, no-cost birth control will still be available to Vermonters. The new law also extends the no-cost birth control benefit to vasectomies, allows dispensing of one year's supply of prescription birth control, and increases Vermonters' access to LARCs by increasing LARC reimbursement rate for Medicaid providers, making the devices more economical to stock - Working with allies to continue advocating for Medicaid expansion in Maine, which is the only New England state that hasn't accepted the federal funding available to extend coverage to its low income uninsured - Supporting campus organizing efforts at colleges across our three states and working with strong Volunteer Action Teams to deepen and grow grassroots organizing capacity - Continuing a partnership with the State of Vermont to implement the Vermont Access Plan, a program that provides free family planning services to eligible low income women and men. In 2016, PPNNE served approximately 4,300 people through this program - Continuing to reach and provide eligible low income women and men with free family planning services through the New Hampshire Family Planning Program. PPNNE served approximately 2,500 people through this program last year - Continuing advocacy in Maine for implementation of the new family planning MaineCare program, which could potentially help up to 13,000 low income Maine women and men gain access to free birth control, STI testing/treatment and annual exams. We were able to begin helping patients submit enrollment applications for this new coverage in October 2016, and this work continues apace.

PPNNE continued to leverage online opportunities and social media to increase visibility, reach young people where they are, and build our movement. A highlight included the continued growth of our popular informational video series. By the end of 2016, our "A Naked Notion" YouTube channel had over 54,000 subscribers and the informational videos had received 6.6 million views.
