approx 1,000 children and women in ten poor neighborhood communities
in and around Cuernavaca, Mexico. Education is provided for children from
pre-school through 8th grade. Music, and computer lessons are also provided
along with meals, vitamins and health care. Over the course of a year more
than 150,000 meals are served, as well as more than 3,400 hours of
academic instruction. Medical services were provided to more than 1,500
patients and dental services were provided to more than 800 people,
all free of charge.
