In 2016 the New England Youth Theatre (NEYT) operated its first full year after completing our Campus Revitalization Project. This project gave our grounds and facilities a full soil remediation, a new parking lot, several new lighting fixtures, and total compliance with ADA standards for our performance space. NEYT also completed our first full year of operating the Town School Theatre program in partnership with Brattleboro's three public elementary schools (Oak Grove, Green Street, and Academy). This program provides free afterschool arts education to young people in our community, working with support professionals as needed to accommodate individual learning differences. NEYT also piloted our new Mentorship Education Program with a grant from the Thomas Thompson Trust. This new program is a professional development initiative designed to connect NEYT students with our region's theater professionals through personalized, advanced, skills-based instruction. During the summer months, NEYT offered 17 different intensive theatre camps, serving 200 students and focusing on skills such as melodrama performance, clowning, theatre technology, and musical theatre. Our two 2016 musical theatre productions included "Mary Poppins" and "The Three Sisters" both of which were supported by live music featuring students in our pit band program. NEYT's inclusive Theatre Adventure Program successfully produced a full production of Shakespeare's, A Midsummer Night's Dream to rave reviews, where actors with developmental challenges delivered their lines with confidence while embodying their characters with conviction.
