In addition to the Cup, the Foundation also hosts a week-long debate summer camp as well as shorter debate training days for groups and schools. Hundreds pass through the debate program each year.

The Coolidge Scholarship The Foundation operates a merit scholarship program that awards full-ride undergraduate scholarships to outstanding high school students. The scholarship program attracts thousands of students each year, each of whom learns about President Coolidge and his values through the course of applying for the scholarship. The Coolidge Foundation conducts a rigorous, multi-stage, review process that culminates with in-person interviews with a finalist jury. In 2016 the first three Coolidge Scholarship recipients were named. The chief criterion is academic excellence. Secondary criteria include interest in policy, appreciation for the values Coolidge championed, humility, and service.

Management believes it is no longer subject to income tax examinations for years prior to 2013.
