

The Agreements provide a lump sum benefit upon reaching age 62, subject to certain limitations set forth in the agreements. The agreements are unfunded and the Credit Union recognizes the cost of future benefits by accruing costs over the required service periods to the date the individual executive retires and recognizes those costs as current compensation expense. Expense recognized in the statement of operations for these Agreements was \$22,682 and \$76,811 for the years ended December 31, 2016 and 2015, respectively. Benefits paid to the retired executives are charged against the accumulated liability. No benefits were paid in 2016 or 2015. Unvested benefits of \$59,929 were forfeited during 2016, reducing the 2016 expense. The accrued retirement benefit included in accrued expenses and other liabilities in the balance sheets at December 31, 2016 and 2015 totaled \$376,826 and \$354,114, respectively. The primary assumption used to determine the accrued benefit obligation was a discount rate of 4.0% at December 31, 2016 and 2015. Estimate future benefit payments to be paid under the agreements over the next ten years are \$620,940, payable in three equal payments of \$206,980 in 2018, 2021 and 2024, respectively. The Credit Union has purchased life insurance policies to provide a funding source for the Agreements. The 2016 Expense related to the Benefit is as follows: Terry D. Lisle \$43,710 Kathleen A. Krommer \$15,887 Jeffrey A. Davanport \$15,376 Kimberly A. Quinn \$7,638.</p>
