PUBLIC AWARENESS - BIAA LEADS THE NATIONAL EFFORT TO RAISE AWARENESS ABOUT BRAIN INJURY DURING BRAIN INJURY AWARENESS MONTH, THE ASSOCIATION DISTRIBUTED INFORMATION KITS AND RELATED MATERIALS TO ITS STATE AFFILIATES AND THE PUBLIC THROUGH ITS WEBSITE, WWW.BIAUSA.ORG. FACT SHEETS AND CURRENT INFORMATION ON BRAIN INJURY PREVENTION ARE PROVIDED ON BIAA'S WEBSITE. DURING 2016, BIAA HAD OVER 1.4 MILLION VISITORS TO ITS WEBSITE. BIAA'S EVENTS RAISE AWARENESS AND FUNDS TO SUPPORT THE BIAA. DURING 2016, BIAA CONTINUED ITS BRAIN INJURY AWARENESS CAMPAIGN. NOT ALONE THE CAMPAIGN'S THEME REMINDS THE PUBLIC THAT BRAIN INJURY IMPACTS EVERYONE.
