The Bureau received and evaluated 3,663 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,339 referrals were accepted for further investigation, resulting in 876 new investigative cases. After initial investigation, 463 cases were closed without criminal prosecution due to insufficient evidence of a crime

The Bureau referred 245 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 197 individuals were initially charged with insurance fraud and other crimes during 2016, and court cases involving 136 individuals reached a final disposition.

The Bureau conducted an industry training seminar on fraud prevention and awareness for insurance agents, and made insurance fraud presentations at numerous local, state and national training venues.
