The Executive Board of IBEW LU 2222 serves as trustee of LU 2222 IBEW Benevolent Fund Trust for as long as they serve on the Executive Board of IBEW LU 2222.

per week serving on the Executive Board as well as being an officer or steward of IBEW Local Union 2222.
