CDISC is a global, open, multidisciplinary, non-profit organization that has established standards to support the acquisition, exchange, submission, and archive of clinical research data and metadata

Technical CDISC develops data standards that allow data for clinical and non-clinical research to speak the same language enhancing the quality, efficiency and cost effectiveness of clinical research processes from the beginning to end (protocol through analysis) of the research process. 2016 was a pivotal year as the FDA (US) and PMDA (Japan) began requiring CDISC standards for submitting data for all new drug applications. With this regulation, CDISC enhanced many of our standards with new releases (Foundational, Terminology, Questionnaires, Ratings and Scales) to ensure alignment with the latest clinical research developments including the development of a new innovative standard, Clinical Trial Registry (CTR)-XML, which makes it possible to build applications that generate submissions for multiple, global clinical trial registries primarily the World Health Organization (WHO), European Medicines Agency (EMA) EudraCT Registry and United States ClinicalTrials.gov easing the burden to patients seeking research trials. Additionally, CDISC developed 9 new extensions to our standards for collecting, aggregating and analyzing data in the following disease areas: COPD, Tuberculosis, Breast Cancer, Kidney Transplant, Rheumatoid Arthritis, Major Depressive Disorder, Diabetic Kidney Disease, Pain, and Ebola.

Education CDISC created an infrastructure to support implementation of the standards, including classroom & online educational courses, pilots and certifications. In 2016, more than 102 subject matter experts provided CDISC education content via 214 events to 5,438 learners across 42 countries.

Events CDISC hosted three global conferences in 2016 which were held in Europe, Japan and the United States. A record total number of 1,114 people attended who represented 192 companies and organizations. CDISC hosted a Strategy Session moderated by the FDA Commissioner and the CDISC CEO, designed specifically to explore how collaboration, global CDISC standards and related enablers can catalyze more efficient and innovative medical research processes for the benefit of all. Leaders in clinical research and healthcare from industry, government, and academia in the U.S., Europe and Japan convened at the National Academy of Sciences in Washington D.C. on key factors and recommendations to catalyze progress in this area.
