ECUADORIAN CATHOLIC CHURCH THROUGH EDUCATIONAL AND MEDICAL PROJECTS IN ECUADOR ROSTRO DE CRISTO (RDC) OFFERS SHORT-TERM AND YEAR-LONG OPPORTUNITIES TO YOUNG ADULTS WHO LIVE SIMPLY AND SERVE ON THE
